

## *Terms & Conditions*

Your kind cooperation is requested in adhering to the following...

A minimum deposit of 50% is required as a retainer at the time the wedding date is booked. The remaining balance is due 2 weeks prior to wedding date. All deposits are nonrefundable, in the event the date changes or wedding is cancelled by the client for any reason. Proofs from the wedding photos will be available online within 7 business days following the wedding and will remain online for 30 days. The thumb drive with the digital images will be delivered in approximately two weeks from the wedding date. If Erin W. Coats is unable to perform to the guide lines of this contract due to a fire or other casualty, act of God, act of terrorism, or other cause beyond the control of the parties, or due to a grave illness of the photographer Erin W. Coats; and if Erin Coats Photography is unable to provide a photographer that is agreeable to the client, then all fees paid by the client will be returned in full, but Erin Coats Photography shall have no further liability with respect to the agreement. If Erin Coats Photography is unable to perform to the obligations in this contract for reasons outside the sole control of Erin W. Coats, she will not be liable for costs in excess of the amount the client has paid. This limitation of liability will also apply in the event that digital images are lost through camera malfunction, damaged in processing, lost in the mail, or otherwise damaged or lost without fault of the photographer, Erin W. Coats.

The client will obtain digital images which may be used for newspaper announcements and prints. Images may only be used for personal use only, and may not be sold or published without the written consent of Erin W. Coats. All rights to images created by Erin W. Coats will remain with the photographer. Erin Coats Photography reserves the right to display any photographs made in conjunction with this wedding as samples of her work for the purposes of window and showroom exhibit, advertising, promotion on the Internet, publication, instruction and professional competition. Coverage plan times must be used consecutively. Time starts when Erin W. Coats arrives and the time finishes when the coverage time runs out. Photographing any specific moment is not guarantee by Erin Coats Photography and she will not be responsible for any missed moments. The client may present Erin Coats Photography with a list of suggested photos, but Erin Coats Photography is unable to guarantee that those suggested photos, or any image will be captured.
